Manager's Report

S Bearth reported on regular maintenance around the property including the parking lot striping being completed, dumpster schedule updated to twice a week and being moved to summer location. All the irrigation has been installed, raking, mowing, and seeding the mud pit by unit 20 has all been completed and maintained. After a report, the crew will be treating for ants with pet safe treatment. The crew is almost done with some walkway repairs by units 20 – 24, and will continue to repair any safety hazards on the walkway.

Financial Report

May is the first month of fiscal year. The association is under budget, but this is largely due to timing of fireplace cleaning and inspections.

Bridge Updates & Letter to Owners

R Leeds shared it would be ideal to get a contractor committed by September to complete the project in the summer of 2024. He explained the first quote received was more comprehensive than the second, and the first quote was cheaper than the second. He further explained that the recommended repairs would last another 15 – 20 years. A Tower asked the reputability of the companies that bid the project. R Leeds explained these contractors are vetted by CDOT, and he is trying to set up a meeting with the contractors for further vetting. The Board discussed the value of the bridge versus the cost of repair or demolition. The Board discussed the letter to homeowners drafted by R Leeds and was in support of sending it to owners. R Leeds will send out another draft letter to be reviewed by the Board before sending to the owners.
